# ED Ponderings

Mel FitzHenry's going to laugh at me. I'm going to act like a rookie, get overly sensitive, and respond to some negative talk that is just too far-fetched. I can just see him shaking his head and chuckling. It's not going to stop me, however.

When I was campaigning for the Executive Director position, I said CASI members needed more honest information about how the Board deals with CASI business. We all need to have the facts. With elections coming up, we need to base our decisions on the truth, not on rumor and innuendo. This article is intended to serve that purpose and to challenge everyone to become part of the process that is CASI.

Donn Shands' column in the June *Terlingua Trails* started me thinking. I want to thank Donn for being so thought provoking. I hope all CASI members read the columns in the *Trails*. The quality of our paper has been greatly enhanced by the efforts of the dedicated writers who submit columns each month.

When considering Donn's thoughts, I added a number of things I've heard broadcast as the truth and knew it was time to state the real truth. Statements, that may have some truth the first time they're told, become distorted when they're repeated many times. CASI elections are coming up, important decisions have to be made, and we all need to make well-informed decisions.

CASI is the cooks! That's all of us; we're all cooks. Some of us choose to serve the membership as cookoff helpers, organizers, promoters, pod officers, referees, Board support, and Board members, but we're all still chili cooks who are doing the best we can for one another. That is the beauty of CASI. We flourish because of the contributions of our many volunteers. If you've served in any of these capacities, you know it's hard work, not glory. The reward is the great satisfaction that you've done what you can to help this generous organization give to others.

Now, let's set the record straight:

Donn Shands wrote, "The average member of the Society feels helpless to even suggest anything for improvement because their voice is lost in the wind."

**TRUTH:** That should not be. The only voices lost in the wind are those that are misdirected to fellow cooks at cookoffs and pod meetings. For the February Board Meeting and again for our June 28 meeting, I solicited agenda items. None were ignored. Ken Rodd also has communicated with the Great Peppers asking them for items they would like discussed by the Board. Every item received is placed on the agenda by me. In February, every one of those items received fair discussion and deliberation. Our meeting was long, but we discussed every issue. Of those who requested action, the decision was often in favor of what had been asked for. When the decision was to not grant a request, it was because of a few reasons: the request was not in the best interest of CASI; the request was for something that did not come under the authority of the Board; the request was cost-prohibitive or something we could not accomplish.

In addition to official agenda items, we frequently receive questions and suggestions by email and telephone. There are many Board members on the job every day to promptly discuss these issues, usually by email. The best interest of the cooks weighs heavily in all of our discussions.

**MYTH**: When items are brought up at Board meetings, they are summarily dismissed as unimportant unless they come from a Director. Most issues have been decided prior to the meeting and dissenting Board members are badgered into accepting the prearranged decision.

**TRUTH**: I can only speak for this current Board. All others are history and are no longer relevant. There are some Directors who remain from previous Boards, but each Board functions as a team with its own dynamic. Anything that may have allegedly happened in the past, whether fact or fiction, is irrelevant and this Board should not be condemned for it.

So far, with the current Board, our dealings have been very cordial, respectful, and businesslike at meetings and in email discussions. Once or twice, Directors have been taken to task by other Directors. When this happened, I think we probably deserved it. It was still done in a respectful manner. We made corrections and moved forward. That's the way any good management team works together in order to do their best job.

On the current Board, there has not been any contingent of Directors who tried to force their agenda on others, and there certainly has not been any badgering. Most of the agenda items at the last Board Meeting came directly from the membership.

Donn wrote about apathy. I worry about apathy as well. Like any large group, we have a minority of vocal members with varying points of view. Being chili cooks, we might be more opinionated than most. Like any society, some of these people exercise their right to free speech with vigor. Their persistent proclamations don't make them right or wrong. We can't allow ourselves to sit back and just go along. How do you know what's right? Only by finding out for yourself.

CASI elections are coming up. It's important for everyone to make their best choices with the best information they can get. Don't accept what is said the loudest as the truth. Mark Twain said, "A lie can travel halfway around the world while the truth is putting on its shoes." The truth can be quiet. It doesn't need to shout. Find the truth for yourself by asking questions of the people you are hearing things about. Go to the meetings and be a witness.


Should you vote for the incumbents or should you vote for new Directors? Are the current Directors doing a good job? Will the new candidates be able to implement the ideas they espouse? These are your decisions. Base them on the best information you can get.

I was disappointed to see so few people attending the Board meeting in February. Apathy? I hope not. It's easy to let the daily grind get in the way of other activities. However, many of you live within driving distance of the Board Meetings. Don't listen to hearsay descriptions of what the Board is doing or not doing. Come find out for yourself. We are not a government with opposing checks and balances. We are a social corporation in which we all have a lot at stake, and we must work together. Knowledge will make us better. If you attend a Board Meeting, I believe you will be impressed with the tone of the meeting and the work that is accomplished. You will certainly be able to make better decisions, based on what you know, not on what you've heard. I hope to see you there.

Irene Duffield sent me a Doris Lessing quote recently that sums it all up...."Think wrongly, if you please, but in all cases think for yourself."

In the upcoming weeks, Susan and I will be in many parts of the country attending cookoffs. We look forward to the opportunity to visit with many of you.

In an effort to clarify "who gets what", the following information is provided:

Any questions you may have regarding ads should be directed to Bob.

<u>AD NOTES</u>: We receive ads in all types of formats. For a quarter page ad, it is best not to send a copy of your cookoff flyer, unless it is very simple and clear – the reduction of 12pt type on a full page will result in 3pt type on the ad – not readable – it is best to either make a simpler ad, or set your original's margins to match the quarter page size. Camera Ready (.jpg) is the preferred medium, however ads in Bitmap (.bmp) or Graphics Interface (.gif) are usable, but reduction may affect quality. MS Word (.doc), Adobe Acrobat (.pdf) and Text Art files require scanning and converting to .jpg format and can affect quality. Documents can be photographed by the printer and inserted during the printing run for an additional \$100 charge and must be submitted prior to the 1st of the month due to direct mailing times. It is suggested that if you submit artwork to be photographed that either Priority or Express Mail, 9x12 Flat Rate cardboard mailers, be used.

<u>PICTURE NOTES</u>: Because of the conversions we have to make for the printer to print the color pictures, dark background or just generally dark pictures will not work. The conversion darkens the picture. We can and do adjust, but generally the product will not work well, and what you see on the computer screen is not necessarily what comes out in the paper

# The Tejas Medicineman Presents: "Chili Chants"

At a recent cookoff, the conversation turned to parking arrangements and safety hazards caused by not enough space. When I made the rest of the rounds visiting, and taking pictures, I made mental notes concerning how people had crammed themselves into a small parking area at the cookoff and potentially were ripe for disaster.

How many types of cooks do we have? Let's see. There is the die-hard Class A diesel pusher motorhome type. The mid class Winnabago type. The pull and fifth wheel trailer types. The camper van type. Then there is the "I'm cooking out of the tailgate or trunk of my car," type. Vehicles, no matter what size, still take up space. If there is very limited space, then people start taking chances and try to squeeze in too tightly.

What are the hazards? Fire is the first concern. If a fire started and got out of control within just one motorhome or trailer, then the potential for catching 3 other motorhomes on fire is greatly possible if there is not adequate space between the vehicles. Then the potential of those 3 catching three more...well you get the point. What can be a potential fire hazard? Butane, liquid gas, campfires, BBQ pits come first to mind. Let's take plain old liquid gasoline first. I had a science teacher show me once that you could put a cigarette out in a can of gasoline. However, if you brought that same cigarette near a container that had a mix of gas and air vapor mix, kaboom. Don't try it on your own. Butane will explode if combined with air and set off with a spark. Both butane and gasoline have heavy ordorants added to them to help identify them in time to ward off any potential disasters. Once, at a cookoff, a cook came into the parking/cooking area with a large class A motorhome. Within a short period of time, there was noticed a raw gas smell. It was diagnosed that a fuel line had begun to leak. He was too close to too many other people and was a hazard. Rather than start the engine and possibly cause a fire, he was chain towed out of the parking lot to a safer area so the hose could be repaired. The area was washed down. Had it begun leaking in the middle of the night, and someone came wandering in, three score into his cups, with a lit cigarette,....well.

I suppose that most of this article comes from enduring a cookoff in Houston, where the fire department was in charge of parking the motorhomes and trailers. Each unit had to be so many feet apart, if you cooked under the canopy, you had to make sure your extra fuel was stored at the front of the vehicle. No gas cans could be at the rear, because they would be too close to the waterheater flame. Liquid and butane gas could not be stored together. We had to store the extra gas out and away from the parked vehicle. To finish off the requirements, each of us had to show that we had a fire extinguisher on hand. The year that the cooks cooked down town, they were not allowed butane gas and had to use Coleman fuel. A full can of Coleman fuel, if left in the sun, can start swelling and spewing gas. The best start for fire prevention is common sense. Find ways to park in rows and allow for space between vehicles. Make sure there is room for "fire and emergency lanes". I think that Ladies State in TX is about the most organized parking for a good sized cookoff. There are fire and safety lanes fairly well established. There still is some potential hazards, but we will discuss them in another article. For now, start thinking safety when parking at a cookoff. Both for you and for the cooks next or near you.

Next month we talk about noxious fumes, and we are not referring to those that can be prevented with Beano.

Just kidding, guys. As a matter of fact, back stage was funnier sometimes than the front. Janie always had to make sure that I got my champagne opened before time to go out, as I was very nervous out there. There was a lot of interesting doings back stage. I remember Carolyn Hejtmancik trying to put one costume on over another. It didn't work but it was interesting watching her try to get it back off.

The Great Southwest Show Team was a good team. I had a lot of fun although I was not as coordinated as the rest. I didn't dance as well as most, so I usually did other things unless someone didn't show up. I remember the year that we were by the porta-apotties at Terlingua. The other show teams wanted us to draw again because they didn't think it was fair that we were; the drawing was fair and square and we stayed. That was back in the days when we looked out for each other.

I also remember sitting on a chair putting on my tennies over my fishnet hose, and a man took a picture. He said that he wanted a picture of someone with fishnet hose, leotard and tennies. He had never walked on those stones in high heels. I am sorry for all of the new ones who never got to see us. It was a good show. I don't think it will ever come back because we are older now, and we have lost many of those who were with us. Those who have gone ahead of us are thought of all the time - Karen, Judie, Carolyn. I feel like I have forgotten someone. If I have, Janie, will you remind me? We were blessed to have them with us in cooking, shopping, show and just having fun.

Duff once received an award for Chilihead of the Year, however the esteemed President of CASI presented him with the one that said Great Pepper of the Year. Duff thought they were making fun of him and said some, um, four-letter words. It finally got fixed and I think that Mayo was the one who was Great Pepper of the Year.

Another award of which I'm proud of is the one from the Houston Pod. Mine says Chili Hall of Fame, but I have heard it called Chili Hall of Flame. Whatever it is, I am glad that they felt that I deserved it.

Duff and I were Chiliheads of the Year for SAP-CASI. Our dear Carol Roy made the trophy especially for us. It has a SAP-CASI pin on it, and for Duff, a cigar, dominoes and dice. For me, it has clown and a bottle in a bucket that I am sure was a champagne bottle. On the top over the pin is a cooking pot. Carol was so creative. She was dearly loved and is missed by us all.

The last two awards are interesting. One is the Chili Bowl Award given by John Raven every year at the Hug In. I was selected for a chili bowl award and for the Tag-A-Long award for the year 1978. I was a groupie in other words. I didn't cook in those days but I judged, worked at cookoffs and helped out where needed.

The last award was from SAP-CASI and made me President of the SAP-CASI Foot in Mouth Club. Yes, even in those days I would open my mouth and stick my foot in it. It seemed that every time I said something that I shouldn't have about a show group or just about anything else, someone overheard and went ballistic. Now that I think about it, things having changed. I still open my mouth and say something that gets me in trouble.

Iread the CASI newsletter (CHN, aka AiDE) this morning and especially the forum. I don't see why people want to cook to see if they can get more points than anyone else. It won't mean anything, as when the Benolds got their points, you needed

twenty-five cooks as someone reminded me recently. Now you only need 15 cooks and it is totally different. When I qualify, I cook only in Pod Cookoffs and big ones like Marble Falls, and I think that most other qualified cooks do too. Cooking in small cookoffs when there are others that need points is, in my opinion, plain out and out wrong. I do not see the glory in winning all of those points, unless it's an ego thing. What goes around comes around, and the day will come as many can testify that you will have a hard time getting a point.

Personally, if I had a good recipe I would save it for Terlingua instead of wearing it out to try to outdo everyone. By Terlingua, most of the good cooks will have some idea what a person that is winning so much is cooking. I have seen others watch as the person in First Place out there was cooking what they cooked, and I would imagine it hurts but that's what happens when you want to get so many points. I don't understand anyone like this and I am glad that I get my 12 points, and I am happy with them. Also there is the idea of tweaking the rules. If they aren't broke, don't fix them. Instead, read them and learn what they say. The idea of a smaller book to give to promoters is a good one. Also help them one year and then they are on their own. Griff and I helped out a big cookoff, and the person running it never did try to learn. We were expected to do everything every year until we just stopped. It was not our job. We were there to run judging and not the cookoff. CASI members need to read the rulebook, and read it more than once if necessary. There are some who I have seen that have seen rules broken right in front of them, and they didn't know that it was wrong. This sort of thing has to stop!

The Alamo Pod made a mistake because the Pod members forgot a rule. There were those at the cookoff who said they thought it was wrong in having two cookoffs on the same site for the same charity or whatever it was. But none of them came and told us. The points were taken away from the cooks. There were those who knew we were breaking a rule months before but they didn't tell us either. The comment was "it was not their job." Making sure that the rules are followed is all of ours job. You don't let a cookoff be held when you know that they are breaking a rule and do nothing to help that Pod. I call that bad sportsmanship. You may not like the people running the cookoff but that should have nothing to do with it. You do what is right and honest. The cooks shouldn't have been punished, and to this day I do not understand what person or persons would stand by and let the cooks loose their points because they didn't think it was their job. It is not the rulebook that needs to be changed, but the people who don't read the rules or don't care enough about them to do the right thing.

When I was Great Pepper of SAP-CASI, there was a cookoff in September that had not been advertised early enough. I told them that if they cooked they could lose their points. All that happened was the cookoff was put on probation. That was a cookoff at which the cooks should have lost their points, as it was a flagrant violation.

I am getting off my soapbox for now; take care of yourselves. Drink all of that good beer and get those spices mixed just right. I am now going to go and do a very small "get those points" dance for Norma, and I think I have to do one for Larry, too. I am not sure about that yet. As soon as I can, I will make those dances a lot bigger.

Love to all of you and hope to be out next year, and it looks as if I am going to be able to!

# **Cell Phone Service Arrives in Terlingua**

Cell phone service is arriving in Terlingua at last. Doug Hill, Managing Partner of Palimino Development Ltd. of Odessa, Texas and a member of CASI, has launched cellular coverage in the Big Bend area with deployment of its' initial site at Study Butte, Texas.

Palimino plans a total of three sites that will provide coverage from Lajitas to Boquillas, a stretch of approximately 60 miles.

"The initial site is a 150' monopole tower and will transmit an analog cellular signal to near Lajitas to the west and about 15 miles to the east towards Panther Junction," Hill stated. "To the south, the Castolon and Santa Elena areas and connecting highways will be covered, for the most part, and there should be a good signal to the north out Highway 118."

The second site is in the development stage with construction planned later in the summer. The Highway 385 site will overlap coverage from Study Butte and transmit to Panther Junction, Rio Grange Village and on down to Boquillas Canyon overlook. The Terlingua Ranch area will be covered to the north and Highway 118 should receive better coverage going north, possibly as much as 30 miles out from Study Butte.

The third site will be along Highway 170 and will provide coverage along 170 and in-building coverage on down to Lajitas.

"The Hwy. 170 site will also provide the annual CASI cooks area with excellent coverage while the Tolbert cook site will be served from Study Butte," said Hill. "Palimino is installing "roaming only" sites and has in place agreements with about 100 cell phone companies from across the US."

"Because of the mountainous terrain the possibility of blocked areas exists, but the type of signal being transmitted is the best for the area. As far as users go, get with your carrier to be sure your phone will default from digital to analog cellular and enjoy making calls from our system," Hill stated.



# Girl's Night Out

Notice they are all blondes. This should throw a lot of the blonde jokes out the window. This item also counters the thought about women typically not working well together. Let this put that one away as well! In one of her songs, country singer Shania Twain croons about all the things women do these days-they are judges, politicians, doctors and soldiers, to name a few. Not mentioned in the song, but occurring more frequently as the global War on terrorism continues, is something else: female fliers in combat missions over Afghanistan.

Early on Jan 31, a KC-135 Stratotanker took off from Ganci Air Base, Kyrgyzstan, carrying more than 180,000 pounds of fuel and an all-female crew — both pilots, a navigator and a boom operator. The event marked the first all-female crew to fly an air refueling Mission into Afghanistan from Ganci. "We've been really lucky," said 1st Lt Alison, the navigator on board. "You don't always deploy with a lot of women. The fact that we have four women on this deployment, and the fact that we make up a crew is amazing." After living with each other in the same tent for almost two months, the women were eager to fly on the same mission. "We've gotten along really well living together, so we were very excited to finally be able to fly together," said Capt Waynetta, one of the two pilots on the mission.

The women, including the other pilot, Capt Heather, and the boom operator, Senior Airman Lyndi, are all assigned to the 99th Air Refueling Squadron at Robins Air Force Base, Ga. They have been deployed here since Dec 9. Once inside the tanker, the women began their pre-flight and take-off duties with an ease borne of plenty of experience and skill. Most of them have deployed before, to places like Saudi Arabia, Qatar, Iceland and Thailand. Between the four of them, they total almost 4,000 flying hours in the KC-135. The flight path to Afghanistan traversed three of the "Stans." The country itself remains a dangerous place. Just a few days before the historic flight, coalition forces on the ground encountered the heaviest fighting since Operation Anaconda last year. Norwegian F-16s from Ganci dropped munitions in support from the air.

Once over Afghanistan, the crew got down to business, refueling F-16s from! the European participating air forces of Denmark, the Netherlands and Norway. Based at Ganci, the aircraft provide combat air support to coalition ground forces. In the refueling world, the motto is, "Nobody kicks ass without Tanker gas." The crew emulated that motto when the boom operator connected two moving aircraft together on a night with 1 percent moon illumination. "It's awesome knowing that I'm having a direct impact on the mission," said Lyndi on her 17th combat mission over Afghanistan. "The fighters couldn't put bombs on target without gas, and I'm the one who gets it to them," she said. More than 50,000 combat missions have been flown in support of Operation Enduring Freedom. In all, Lyndi refueled 10 European F-16s during the flight, off-loading 63,000 pounds of fuel. "I'm accomplishing something with my Air Force career," said Alison. This is especially true in the case of OEF, an operation that more than 1,800 women support, according to the public affairs office at Central Air Forces, the air component of U.S. Central Command. "I've always thought the greatest thing I could do with my life was to serve my country and be willing to die for it — for my family, my neighbors, people I don't even know," Waynetta said. "Now, we're here supporting troops in Afghanistan who are defending our freedom and way of life." Basking in the early morning sunlight, the tanker headed back to Ganci. As the snowcapped mountains poked out above the clouds, the women reflected on the significance of the flight. "All we wanted was to fly together," said Lyndi. "I'm so excited we got to do it." "We believe in equality," Waynetta said. "But, the fact of the matter is, we're still girls and we're doing something our grandmothers couldn't do.


