

ED Ponderings

I'd like to solicit everyone's help with the CASI book that Turner Publications is working on. First, a little background:

Last June, Jake Austed with Turner Publications called to propose a coffee table book about CASI and chili. Mr. Austed detailed the background of the company and explained his concept of what the book might be. He assured us that there would be no cost or obligation to CASI and that five percent (5%) of the pre-sale sales would go to CASI. We talked about the Scholarship Fund as a good place for these proceeds.

Mr. Austed followed the meeting with a letter and a sample of their work, a book on the history of bourbon. He then came to Lebanon, Tennessee during the North American Open and met with Renee Moore and me. We invited him to present the program to the Great Peppers in Little Rock, which he did. Jake set up a display of some of their books and spoke about the project in the general session, answering questions from the GPs. Based on the favorable response from the GPs, and again verifying that there would be no cost to CASI, we commenced the project.

Randy Baumgardner is the Editor in charge of this book, and his job is to gather and mold the information. At this point, the concept of the book is a telling of the CASI story through a number of directions – Pod histories, statements from TICC champions, regional recipes, and more. December 30 was set for the first deadline for material to be submitted, and I think there are more than a few Great Peppers busily doing research. After this first wave of material, there will be a second collection deadline.

Based on the examples we've seen, this is going to be a beautiful book on CASI. We need to make sure the content is equal to the format. Please contact your Great Pepper, so that your story can be included in the book. Call your GP with your memories of Pod and CASI history and of chili personalities you've known. If you have information that does not seem to fit the Pod format, please let me know so I can help you get the information to the Editor in a meaningful way.

Let's work together to make this a book of which we can all be proud. Thanks.

Many of our members are really not aware of what the Elks are or do. There are Elks Lodges throughout the United States. You have probably driven past some and wondered what they do. World War I found the U.S. poorly prepared to fight in the war. The Army had NO base hospitals to care for mass casualties. The Elks donated one million dollars to be known as "the Ware Relief Fund". The Elks were the first to arrange to finance and equip two base hospitals in France. Of the 475,000 Elks members, over 70,000 served in uniform.

World War II found the U.S. with nonexistent air power. The Elks helped with the "Keep'em Flying" program that produced the initial "air cadets" for service. There was a dire need by the Army and Navy for skilled construction workers, and they turned to the Elks for help. The Army Engineers and Navy Seabees got all their recruits three months ahead of schedule.

The Elks have been assisting veterans since the end of WWI with education training programs, medical assistance and more.

The Elks are not only involved with national charities and assistance, but also on the local and state levels assisting in many important projects. This column could not even start to list all their accomplishments.

Elks Lodges are excellent locations for potential chili cookoffs. They are involved in charities, they are involved in their communities and they are friendly people. The next time you drive by one, stop in and say hello.

For sure if you're in the Dallas area, stop by the Irving Elks Lodge and tell them you are a CASI Cook. Now I can say that I have warned you; you will have a great time with great people regardless of where you are from. They would be proud to have you become an Elk.

It makes the frustrations and abuses Judie and I went through when we were starting to organize CASI worth all those issues we faced. Along with Vann York, Richard Knight and Paul Smith, we only had visions and dreams of CASI progressing to where it is today. It is due to hundreds of chili heads', too numerous to list, hard work that we have grown to this magnitude.

Three hundred and twenty-one chilis (321) turned in for judging - think about how awesome that number is! Every one of these cooks had to win points and qualify to be there to participate. We had 321 winners cooking. There are no losers at CASI TICC, they are all winners. Sure there were cooks that placed ahead of some of us, but everyone else was still a winner. Just being there and participating should make you feel like a winner.

Speaking of winners. Honey Jones will be a terrific representative for CASI. Wasn't it great to see a cook place at TICC in their first year of cooking? A husband and wife (Johnny and Frances Sullivan) both placing in the top ten. It happens in small local cookoffs, but very seldom in Terlingua. I can't remember if it has ever happened before, but I'm sure if it did you will let me know. Then there was Sharon Roy placing fifth. It has taken her twenty-three (23) years to get on that CASI stage. Can you imagine the cookoffs she had to participate in and the number of points she accumulated in 23 years? That's dedication and perseverance. Bill Dees, the San Antonio spice King, made it. Maybe we better check out the spices he sells. I always need all the help I can get each year. I know there were others I should mention, but I had to make a run to one of the little green rooms in the middle of announcements.

Richard and Carol Knight were named our Chili Heads of the Year. They certainly deserved the recognition. For those of you who don't know, Richard is the person who designed the CASI logo that is still in use today.

Being able to use our cell phones in Terlingua was a delightful experience. I remember when all the news media had to wait in line to use the one phone at Glen Pepper's Villa de la Mina. We have come a long way. Royce Gilliland, Vann York, Pat Irvine-King and I rehashed the trials and tribulations to get the first CASI pepper trophies made. Vann came up with the idea of the pepper for a trophy. He wanted a trophy that would be recognized anywhere you saw one. On someone's mantel, trophy case or in a picture. When you saw it you would know that it was a CASI Terlingua trophy. The three of them made it happen. The only problem was CASI had almost a zero bank balance. Royce made them on credit and CASI had to come up with the money. Thankfully I had a strong relationship with Gaviscon at the time, and I told Jeff Dillon the situation. He called Vann and told him two wonderful words, "They're covered".

I've got to mention the CASI Board of Directors. When they screw up, I'm usually one of the first to comment about it. But, when they deserve a compliment I will be the first in line to praise them. I saw them working in more areas and more active at this TICC than some of the past events. They worked hard, kept the announcements on stage down and kept the rhetoric more constructive. I know all the things they have to do to keep that event running smoothly. There are many problems and frustrations behind the scenes that none of us cooks ever see or hear about. Thank you ladies and gentlemen of the CASI Board.

I know some of you will say I'm getting really fluffy with this article, but that's your problem. I had a great time at CASI TICC this year. I appreciate the participation and hard work by every chili head to make this cookoff enjoyable for me.

I'm damn proud to be a CASI chili cook!

A View From The Top of an Old Chilihead

Coming up with a subject each month for this article gets easier every month. If you have been around chili as long as I have, there is a story everywhere you look and they all pertain to chili. One story will always remind you of another. Some you can publish and others we will leave buried. I will not write about cooks' personal indiscretions or mine. I will not name names of those living or dead. There were a lot of indiscretions then and probably just as many now, but that's not chili history nor constructive chili news, it's gossip.

Clicking through the photos on the CASI web site, a picture jumped out at me. Its caption is "Yeller Dog, Tupelo and King James". It is very significant to chili history and probably no one else would recognize it for its significance. At the time, the only one in



the picture I knew was Yeller Dog. It was much later that I met and got to know King James. I still don't know who Tupelo is or was. On the right side of the picture is the back end of a Winnebago Motor Home. That is my motor home, and I made the mistake of parking next to the Yeller Dog Gang Show Team. They had this homemade cannon they liked to shoot during their show. As the day wore on and night came, a lot of beer was consumed and

that team got louder and louder. Every time I would almost get to sleep, they would decide to fire the cannon. This was on Friday before the chili cookoff on Saturday. By Saturday night, the ones remaining at the site were getting tired and some must have gone home because the noise died down to a normal decibel level. They did have a very large time at every cookoff.

What has this got to do with chili history? Nothing pertaining to their show team, except there were two very outspoken people in that picture that missed the chili history taking place on Saturday next door to their site. They were so busy having fun, they missed the opportunity to come over and put their two cents worth in. I know they both will hate to hear this twenty-seven years later, but time flies when you are having fun. This was the Flatonia Chili Cookoff in 1978.

I had been talking to cooks, show teams, promoters, sponsors (not many in those days), spectators, big-breasted women and anyone else who I ran into at cookoffs. I took copious notes. We had one of those new rear kitchen model RV's that we thought we just had to have. After two or three trips, we hated the floor plan. In 1978 at Flatonia in the back of my RV, I started to organize my notes to write the first CASI rules. I recruited Jan Loop to act as Secretary and write a draft of the notes. She seemed to be one of the more coherent people who could still write, although when I started to write them up two days later the draft was just a little difficult to decipher.

Judie, Vann York, Jan and I started the draft from my notes. We had difficulty understanding some of the notes; fortunately most of the people were at that cookoff that I had talked with when writing the notes. Judie would go and find them and bring them to the RV to rehash their suggestions or complaints. I can't remember everyone who came in except Clyde Griffin. He had the longest list of pro and cons. In those days, Clyde was in his prime and very assertive.

In every hundred notes, fifty percent were the same subject, thirty percent were bitchy nonsense that were thrown out, ten percent were about show, and ten percent contained good constructive advice. We had our first draft of the notes reduced down to about ten handwritten pages, including the rules of judging chili. I still needed to finalize the showmanship rules. I had made a rough draft of them from my notes and it was less than one typewritten page. None of the people who had come to the RV that night were show people. They only wanted to talk about chili.

I was sitting by the window and the first show person to come by was Ron Charlton. I stopped him and we discussed showmanship through the window. I told Ron that I had a draft of showmanship rules and read them to him. I asked him to comment on what he thought should be added or deleted, but keep it brief. Obviously, I did not know Ron very well at the time. You couldn't ask Ron to talk about anything and have him be brief. In school when the teacher called the roll, Ron probably delivered a dissertation just

to say present. We were at this for several hours, and I was suffering from sleep deprivation thanks to my show team neighbors, so we called it a night.

From Flatonia a large contingent of cooks went to Del Rio. We stayed at the Holiday Inn RV Park outside Del Rio, which is the same one the cooks stay at today and have a cookoff on the way to Terlingua, although the park now has a different name. In 1978 the park was owned by Ed Measles brother-in-law and sister (Ed started the Comfort cookoff in 1977). The stay in Del Rio is another story for a later time. I could write a book on that RV Park alone. Monday morning at 3:30 or 4:00 AM suffering from one of the worst hangovers I have ever had, when all my senses were very keen, I took the rough draft and typed up the first CASI rules. I reduced it down to less than three pages including judging and showmanship. Damn, that old portable typewriter going peck, peck, peck made my head hurt.

The Tejas Medicineman Presents: "Chili Chants"

Maybe this time we'll get around to talking about how we save our memories. Several things happened during this last month that caused some of us to have to dig into old boxes in the attic, pull old photo albums out of closets, and sort through hundreds of files looking for certain photographs. Some were looking for photos for a history anthology they are working on and others, like myself, had the unpleasant task of rounding up photos of our departed friend, Ron Charlton.

I turned up only five photos of Ron. Someone, fortunately, took a picture of him at the cookoff the weekend before he passed on. I was sure that I had more, but I have a feeling some were lost in a recent computer crash. This is the second time that I have had to produce photos for the *Trails* for those departed. No one has assigned me that task; I just do it because I can.

As some of you might know, the past few years have dealt me some severe blows. One was the Great Houston Flood. I was smart enough that last time I learned (after being flooded before) to never stack photo albums on the floor or put them low in the bookcase. One box of loose photos did remain low on a shelf and got soaked. I had to wash every photo before they dried and stuck together, and lay each one out to dry. At the time, the only dry place was my camper. I had pictures drying on almost every square inch of available space. It was close, but I almost lost some very rare personal and chili family photos. The recent computer crash also taught me to be even more cautious about keeping valuable documents safe.

Now when I return from a photo shoot at a cookoff, I burn a disk of the photos then and there, and that copy goes into a safe file drawer should I ever need it. The disk only costs 35 cents, and it is money well spent.

Some are not so fortunate to have upgraded to digital as yet. Most of the photos that were taken at Terlingua this year are probably still in the cameras. Those rolls that did get developed were usually produced in duplicate so you could share them and still keep one. A month goes by with the photopack on the kitchen table, and then it gets put in a shoebox with the other photopacks with a pat and a promise to someday get around to putting them into a photo album, which usually never happens.

The 21st Century brought us affordable computers and affordable digital cameras. Mix those two with the galloping technology of the internet, and people found ways of sharing their photos across the world. Everyone suddenly became a wannabe newspaper editor and found ways to put up some really inane websites. Normally personal websites don't last very long. The Webmaster soon finds out that coming up with new material to keep people interested is tougher than they expected.

The worst offender is the Blogger who sort of keeps an on line diary of every thing they do, including what they are that day. What a way to keep a memory bank. Get a life! A website has to maintain some semblance of social redeeming grace.

The best thing that has happened to the chili world is the use of the web to produce a newsletter that is e-mailed to the world just about every day. The next is that several CASI Pods across the USA are now using electronic newsletters to save time and money for their Pods by publishing on line and saving the postage.

Each of these Chili Scribes are learning the value of digital cameras and to be more astute when at a cookoff so that neat pictures and stories can be gathered to keep the newsletter fresh and fun.

This month's PC Magazine has an excellent article concerning how we should store our electronic pictures and data. Those of us who have the equipment, the will to learn something new, and take the time to do it are learning to go back into those old albums and shoeboxes and scan into the computer those old memory photos. The magazine predicts that this year we jump from just storing on CDs to storing on DVD disks that have 4 and 5 times the capacity. The DVD technology will be readable for better than 10 years, and then we will need to transfer the data again to something even newer.

But old habits don't die easily; most of us will burn the disk, and it, too, will wind up in a shoebox. At least the photos don't fade. Just don't expose the disks to a lot of heat or sunlight. I put a CD disk with pictures of CASI TICC cookoff events into the last time capsule. Eight years from now, it will be interesting to have someone publish some of those photographs.

Do you realize that right now it is extremely difficult to find any photographs of any quality of the first TICC Cookoff on the new Rancho site? 1990 does not seem that far off, but remember, there were only film cameras and analog video available then. Maybe we can explore this further in another article, but for now start thinking about how you can preserve your precious photo memories. Join the $21^{\rm st}$ Century and learn some new computer and photography skills.

Try to remember the next time you take a chili photo, that 10 years or even more from now, we don't want the historians to think that 95% of the photos ever taken of chili cooks are represented by two or more bleary eyed people proudly holding a beer in a koozie in front of them. I can remember when the pictures didn't have koozies or Alladin cups, just the beer cans.






