

ED Ponderings



There has already been considerable discussion about the Little Rock GP Meeting credential problems. This will be the last, but we need everyone's help. We could face a scenario where a Pod would not be seated because there just is not enough time to process their credentials. This is unacceptable for all of us. By the time we are on site for the meeting, there are other responsibilities to take care of. We can handle a couple of emergency situations, but if many people brought their paperwork with them to the registration desk, we'd never get them processed, even if we neglected all other obligations.

Two changes will be made to the process based on discussions at the Board Meeting. The first change will be the elimination of a deadline for return of the credentials packet. Packets will be sent with the notation "due upon receipt." We'd like all Pods to be ready to complete the forms and send them back immediately.

For the second change, the Board plans, at their July 17 Board Meeting, to amend the CASI Bylaws to include details about the annual credential requirements. These amendments may include standardized penalties for non-compliance and tardiness. As per the Bylaws, any proposed changes will be sent to the Great Peppers for review and comment at least thirty days before the meeting.

We really just need everyone's help. I'd like to ask everyone's assistance in making the process go smoothly this year. There are several things that would really help:

- Hold pod elections earlier. Elections can be held any time.
 The new officers' terms begin on October 1 but deciding who the officers will be can be done at any time.
- 2.) Check packets for completeness before returning them. Incomplete forms make extra work for everyone.
- Verify that all Pod officers and Referees have paid their CASI dues for the upcoming chili year. Many Pods gather the checks and send the memberships in with their packets.

I'd encourage everyone to do this and make the process go smoothly. Credentials cannot be issued until membership verification for all officers is complete. Thanks in advance to all you for your assistance in this endeavor.

We'll be traveling the chili trail in the next few months. Susan and I look forward to the opportunity to visit and learn from you. See you there.

Police Blotter

This month's Police Blotter example will demonstrate two sides of one of our rules; one legal, one not, but both cause problems.

As you know, there must be a CASI Referee on site for a cookoff to be sanctioned. That Referee can be an Area Referee, a Regional Referee, a Great Pepper, or a CASI Director. Occasionally, it could be possible that none of these designated Referees are available to attend a particular cookoff. In that case, there is a provision that allows for "an authorized CASI representative" to referee the cookoff. Herein lays the start of the problems.

By this time of the year, I'm pretty familiar with the names of the Referees sending me paperwork. Also, the CASI Executive Director (I promised not to mention names) sends me updates to the GP, RR, and AR lists. When I come across a name I don't recognize, I first go to these lists. If I don't see the name I'm looking for, I look at the Area Referee list for nearby Pods. If I still haven't found the name, I contact the ED to see if this person has been added to a Pod's AR list. If he confirms that this individual is not a CASI Referee, I contact the responsible Regional Referee. They may have to contact a Great Pepper, but in most cases will confirm that the individual was, indeed, authorized to referee the cookoff. So there has been no rules violation, just a lot of chasing around which delayed the processing of the cookoff results.

I would ask that if you are a Referee or Great Pepper and have asked some other individual to referee a cookoff, that you let me know of this situation prior to sending in the paperwork.

Here's the other side of the story. A while back I received paperwork that was signed by someone I did not think was a Referee. After going through the above exercise, it was confirmed that this person was not a duly appointed Referee and that no one had authorized them to referee the cookoff. This could have been disastrous had there not been an Area Referee in attendance. So the paperwork was returned to the Regional Referee to get it signed by the AR who was at the cookoff. Yes, this did certainly delay processing the results.

There were several breakdowns here. The Regional Referee is ultimately responsible for coverage of the cookoff but didn't make sure it was. There was a Referee there and why they didn't sign the results sheet is a mystery, but the biggest mystery is why someone would sign a results sheet when they were not authorized to do so.

Everything worked out, but it took considerable unnecessary effort to do so.





Dean Seeks Second Term as Executive Director

As I sit here writing, I can't believe seventeen months have passed since you were kind enough to allow me to serve CASI as its Executive Director. They have certainly been wonderful months. Through the beauty of email, I've been able to regularly visit with hundreds of CASI cooks – the best people in the world. I've been able to participate in cookoffs in nearly a dozen states, seeing in person how successful our organization is. I've grown a lot from these visits.

When I ran for ED, I set four goals: 1). To give cooks a voice and to involve them in the important work of CASI. 2). To develop some publications that would help us have more successful cookoffs. 3). To help pods find new energy to grow. 4). To spread pride in CASI.

I feel we've made progress toward these goals. The CASI Hot News (CHN) has a very active participation. Discussions in the Forum have resonated and brought excellent suggestions for endorsement by the Board.

We currently have a broad-based committee working on ways to help our cooks and cookoff organizers find greater success. We've begun a certification process for CASI officials. We expect this work to yield results by September. I have worked to be the best possible CASI cheerleader, helping keep the focus on what is best about CASI. I've helped us celebrate our TICC Champion on national network TV, and I've coordinated the writing of a coffee table book about CASI and it's history.

Still, there is more work to do. I would like to ask for your support for my candidacy for a second term as ED. We're moving in the right direction. I'd like to have a little more time to help us along the path.

There are significant challenges facing CASI in the next couple of years, and I want to be able to work for CASI as we deal with them. I hope you will support my efforts.

As always, I'm interested in your thoughts and concerns. I invite you to share your ideas with me through emails, telephone calls, or in person on the chili trail.

PREPARATON OF CASI CUP TICKETS

Instructions for Use

Place the CASI ticket with the perforations (Figure 1 "C") down, near the bottom of the cup, with the number and "Chili Cookoff" inscription facing out away from the cup. Fold the cover flap over the number at the scoring. Cut an even piece of tape (gray duct tape works well) about four and one-half inches long. Place tape over part of the marker and cover flap so that the sides and bottom are sealed by the tape (Top is sealed by the bend at the scoring – See Figure 2 below.)

Some contestants are "superstitious" and do not want to know their cup numbers. You may fold along the short end scoring to conceal the contestant's part of the number. (See "B" in Figure 1.)



Contestants should separate their own cup tickets, either when they sign their names or when they turn in their chili. This ensures that the proper name strip is matched with the cup in hand.

Cups made in this way may be kept stacked and sleeved for long periods of time or for transportation without the lids on them. Also, they will be less likely to be damaged or marked, and they will be a lot less bulky than if they had their lids on and were contained loose in a big trash bag or box.





Just What Jobs Do the Board Members Perform?

In an effort to assist the CASI membership in determining if they desire to seek a seat on the CASI Board of Directors, job descriptions will be run in the *Terlingua Trails* during the next few months. Please direct any questions in this regard to the individual currently holding the position.

Please remember that when you run for the CASI Board, you are running for a seat on the Board and not a specific job. Board members are elected or appointed to specific positions. The only exception is the position of Executive Director.

Job Description – Executive Director

The Executive Director position is a full-time job. Candidates for this position should be very committed to the future of CASI. The Executive Director's responsibilities fall into several categories: daily administrative work, TICC assignments, Great Peppers' Meeting, routine monthly duties, and routine quarterly duties.

The CASI Bylaws direct, 'the Executive Director is the principal administrative officer of CASI and is in general control all of the daily business of the corporation.'

Daily Administrative Duties

- 1. Respond to member requests for a wide variety of information.
- 2. Receive and respond to website requests for information.
- Receive requests for "I want to have a cookoff" and either put them in contact with a CASI pod in their area or coach them through their event if they have no CASI activity nearby.
- 4. Help promoters find referees.
- 5. Keep the Board informed of all activity.
- Take responsibility for a professional, cooperative working environment for the Board.
- 7. Direct the Board's electronic discussions.
- 8. Electronically poll Board for consensus on discussions.
- 9. Serve on the Board Rules Committee.
- 10. Coordinate discussions of the Rules Committee.
- 11. Write findings and consequences of Rules Committee and take appropriate actions.
- 12. For issues that require mail ballots, prepare ballots, cover letter, and master tally form and send to appropriate voters.
- 13. Travel extensively to cookoffs throughout the country in order to understand unique challenges in a variety of locations.
- 14. Promote CASI everywhere.
- 15. Coordinate CASI in the media.
- 16. Coordinate CASI Officials' Certification Program.
- 17. Conduct officials' seminars.
- 18. Publish CASI Hot News.
- 19. Order stationery supplies needed by the Board.

TICC Duties

- 1. Prepare TICC Board assignment chart.
- 2. Confirm any outstanding TICC assignments.
- 3. Perform early check-in with stage announcer.
- 4. Develop TICC stage agenda.

RUMOR CONTROL

We are going to divert, momentarily, from the normal reporting method in order to stop the rumor and misinformation that seems to be circulating.

The CASI Bylaws mandate "The Board of Directors is responsible for providing direction for the affairs of the organization." More specifically, the President "shall in general supervise and control all of the business and affairs of the corporation." Following these directions, Mel Fitzhenry has made numerous arrangements in the Terlingua area that have yielded great benefit to CASI. Some of these negotiations have been for financial gain, others have provided work to the ranch that have greatly improved the facility for TICC. Some projects have provided both types of benefit.

On the weekend of February 21, a group, represented by a local Terlingua business, was granted use of the ranch for staging a bike race. This group was closely supervised and all of the CASI property was carefully used, inventoried, and returned in good condition. The grounds were left in better condition than they were in at the beginning of the weekend. The bike race supplied appropriate insurance for their event. The organizers also paid CASI five hundred dollars for this use.

This use of the CASI ranch was a very successful endeavor. We made a little money and we made a lot of friends. The newspapers have trumpeted what a great neighbor CASI continues to be.

Like most of the every day business conducted by the President and the Board, this would normally be reported and distributed in meeting minutes, in Terlingua Trails columns, and at the Great Peppers' Meeting.



Virus Attack

You're minding your own business, and one day you get e-mail from someone you've never heard of, and they're asking you to stop sending them e-mail. Or worse, they're angry. Or worse yet, they accuse you of sending them a virus! But you don't know them, you've never heard of them, and you know you've never sent them e-mail

Welcome to the world of viruses, where you can get the blame for someone else's infection. And there's worse news to come.

Before I get to that, though, there is always a small possibility that your e-mail account has been compromised. The solution there is simple: change your password immediately. That should prevent someone who's using your account for malicious purposes from continuing, assuming you've chosen a good password.

But these days that's not the most common cause for the situation I've described. Viruses are. And what's worse, there's almost nothing you can do.

The MyDoom/Novarg virus currently running rampant is a great example. The virus infects someone's machine, and then looks in the e-mail address book on that machine, and e-mails a copy of itself to everyone it finds. What it also does is forge the "From:" address for the e-mail that it sends. What does it use to forge the address? Why the addresses in the address book, of course. So an infected machine will send e-mail to everyone in the address book, looking as if it was sent by other people in that address book, even though it was not.

Let's use a concrete example: Peter's machine gets infected with the MyDoom virus. In his address book are entries for friends Paul and Mary. Paul and Mary have never met, have never exchanged e-mail, and do not know each other - they each just know Peter. The virus on Peter's machine will send e-mail with the virus to Paul looking like it came from Mary. Paul may wonder who the heck this Mary person is and why she's sending him a virus, but she was never involved.

If you're in Mary's place, you can see that it would be frustrating to be accused of something that you had nothing to do with and have no control over.

For the record, your e-mail address may end up in the address books of people you don't know as well. Various e-mail programs will automatically hold on to additional e-mail addresses that were included on e-mail you received, or possibly from e-mail that was forwarded. Viruses have also been known to use other sources of e-mail addresses, or even forward them around as the virus spreads. What that means is that the simple "friend of a friend" example I used with Peter, Paul, and Mary, while simple and certainly possible, is not the only way your e-mail could show up in a forged "from" line.

What's important here is simply this: one way or another, e-mail viruses lie about who sent them.

If someone accuses you of sending a virus-laden e-mail, and you are positive you did not, then you have very little recourse other than trying to educate them about how viruses work. Point them at this article if you like. But be clear: you're not necessarily infected, nor is the person who received the mail claiming to be from you. It's some third party who is. (And identifying that third party is difficult - this is why virus writers use this technique.)

And of course be sure that you're not going to get infected yourself: don't open attachments from people you don't know, and make sure you have an up-to-date virus checker and virus definitions file.
