Jim Taylor reported:

- A preliminary drawing of a new pavilion had been prepared for outside bids.
 Options included:
 - a. 40 x 50 ft. pavilion on a 60 x 50 ft. concrete slab
 - b. Moving the storage trailer
 - c. Adding extra area to the slab for expansion
 - d. Moving beverage and CASI merchandise sales to the new pavilion
- 2. Currently costs have ranged from approximately \$6000 for the building, to a turnkey contract to include construction for \$9500.
- Motion was made by Jimmy Taylor to construct a 60 x 50 ft. concrete slab, 40 x 50 ft. metal pavilion, enclose the rear 10 x 40 ft. section, relocate the storage trailer, clean and level the area between the existing judging pavilion and the EMS parking area. Seconded by Myrl Coultas.

- 3. A new location for the porta-can placement in the vendor area is being reviewed.
- 4. A source for a marble memorial board has been located.
- 5. A government surplus water tank truck has been located and may be suitable for dust control watering.
- 6. An artist rendition of the new pavilion is being researched to present to possible sponsors for the pavilion.
- Motion was made by Jim Stateczny to level and make accessible a new parking/camping area for spectators beyond the test hole, across the creek from the 1999 camping area addition. Seconded by Myrl Coultas.

TICC 1999 Review

Discussion items:

- 1. Hernandez Trash Removal plans to submit a bid for TICC 2000.
- 2. Traffic control is a major concern.
- Motion was made by Jim Stateczny to restrict traffic in the contestant camping and parking area to cooks, judges, show teams and VIPs. Only authorized traffic will be permitted beyond the 2nd gate. Seconded by Guy Smith.

- 3. A rule change is needed to require one member of each show team be a member of CASI to participate in show at TICC.
- 4. TICC registration will be moved to the VIP area at the rear of the presentation stage.
- 5. TICC contestant and official shirts will not be offered for sale to the public.
- 6. Fire extinguishers will be made available in the public areas and Old 320 cooking areas.
- 7. A bid for security has been received from the Bexar County Sheriff's group.

Other Business

Motion was made by Jim Stateczny to provide any promoter up to 100 judging tickets per cookoff at no charge, to be mailed with packets. Seconded by Jimmy Taylor.

SUGGESTIONS PRESENTED TO ALCALDE

- 1) Find a permanent solution for the dust problem. Perhaps oiling the road or placing gravel on all road surfaces.
- 2) Limiting access to the cooks area to cooks or Old 320 Members only.
- 3) Install hand rails on both sides of all steps leading to the stage areas for safety reasons. (Currently only a center rail exists)
- 4) If fill material is available, close the ravine behind the Homesley camp site. (Several injuries have occurred by people wandering into this area after dark)
- 5) Any suggestions for electrical service be placed in the water well file. No one knows who started this rumor, but the consensus is to forget it.
- 6) Move porta-pots away from Old 320 cooking area.

BOARD DIRECTION REQUIRED

Lynn Hejtmancik has asked what procedure is required to transfer the name of the site originally in the name of Carolyn Hejtmancik (currently listed in Old 320 records as Hejtmancik Estate) to his daughter, Diane Barton. The current rights and privileges state "Should the shareholder so choose, they have the right to "will" the usage of their cooksite, upon the expiration of the shareholder, to someone in their immediate family". If, as the executor of his wife's estate, can he designate this site as his daughter's.
