As with all our major sponsors, their only formal agreement with CASI was to support the Terlingua International Chili Cookoff, and they have gone far beyond that. They have supported many Great Pepper's Meetings and local cookoffs and they deserve our gratitude and our continued support of their fine products. Please notify cookoff promoters that they should not request further

promotional assistance from McCormick unless it's at the request of McCormick.

The Pinkerton Tobacco Company of Richmond Virginia has tentatively agreed to be a Silver sponsor for the Terlingua International Chili Cookoff. They are the manufacturers of Red Man Chewing Tobacco. We look forward to working with them. You should not make requests for them to support local cookoffs yet. Nabisco (crackers), Adams Extract (spices), Durkee/Frenchs (spices), Coors, and Pendrey's (spices) have expressed interest in being a sponsor. I am establishing a sponsorship committee to help with the job of contacting and corresponding with sponsors. This will serve three purposes, it will help me with the workload, it will allow for more frequent local contact with the sponsors, but more importantly it will provide continuity when this job is passed on to the next sponsorship chairperson. Mr. Jeff Dillon, who represents Gaviscon, has requested that you be sure to include your anticipated local cookoff sponsors on your Sponsorship Request Form. They are particularly interested in local food and drug stores.. They would like to arrange some "co-opp" promotions with local merchants.

Mr. Larry Alderson of Wolf Brand Products and Mr. Robert Raines of Quaker Oats had a great time in Terlingua and are very excited about the promotional possibilities of their association with CASI. You can expect them to be more visible in Terlingua this year.

Remember our sponsor's resources (time and money) are limited. Please be considerate of this. Submit your request forms, but don't be disappointed if they cannot support your cookoff. Their only commitment to CASI is to support the Terlingua International Chili Cookoff. Support of you local event is based on the strength of the request you submit. Sponsors are not expected to respond to every request that they receive. This is too much of an administrative burden. I can assure you that they look at every request, and they will contact you if your event fits into their budget and marketing plans.

"WHAT'S A CHILIHEAD? ASK ME."

A little over two years ago, I began my quest into the fabulous world of chili cooking. Shortly thereafter, Myrl Coultas of the Tucson Pod gave me some stickers expressing, "What's a Chilihead? Ask me."

I placed these stickers on all my carrying cases and on the cover of my cook stove showing the world I was a member of a great society of chili lovers.

Occasionally, curiosity seekers at the cookoffs would ask me, "What's a Chilihead?" I would proudly respond that Chiliheads are the dedicated people who appreciate good chili and cook all over the country in almost all kinds of weather to raise money for charities too numerous to mention.

I didn't realize at that time that this was only a part of the definition.

The weekend after Terlingua, I participated in two cookoffs; Casa Grande, AZ on Saturday, and Vail, AZ on Sunday. On my way back home from the latter, my "new" 1977 RV died on the interstate. It was getting dusk. Not one of the hundreds of cars that passed me attempted to offer help, even though the road reflectors I placed out signified that I was having problems. Not even the normal flow of state police went by.

Then came along Diana and Tony Spence, formerly of Houston, Texas and newly established as citizens of Arizona. After Tony did a little trouble shooting to no avail, the Spences drove my friend to a garage where a tow truck could be hired. They then followed the tow truck back to my disabled vehicle, again followed the tow truck back to the garage, and then drove another eighty miles out of their way to drive us to Sierra Vista.

Diane stated, "They only stopped because I was wearing a chili shirt!"

I would like to add an addendum to my definition of what a Chilihead is: It's people like Diane and Tony who are true Chiliheads. They do not just appreciate chili and cooking to raise money for charities, but they also care for a fellow chili cook by showing compassion when I was in need. And they did this so graciously, and would not a any type of compensation for their time and gasoline.

My sincerest thanks to those two Chiliheads.

This letter is in response to our telephone conversation.

I would like to tell you a little about CASI (Chili Appreciation Society International. CASI is a 55011(c)3 IRS Charitable organization whose purpose is to raise money for organizations in need. CASI is made up of chili heads from around the world who belong to local and area organizations called Pods. Although one does not have to be a member of CASI to participate in chili cookoffs, CASI is the nor organizational body of the chili world. We have purchased 320 acres of land in Terlingua which is known as Rancho CASI de los Chisos where we hold our annual International Chili Cookoff. You may have noticed the highway sign stating that we have adopted 1 mile on each side of the entrance to our property to be kept clean through the "Adopt-A-Highway" program.

Last year we awarded a academic scholarship to a senior from the Terlingua area. The ward went to John Klingeman, son of John and Maria Klingeman. We will continue with the scholarship as he continues his education at Sul Ross State University. With the proceeds from this year's cookoff, we have made the following donations to your area: \$1,750.00 to the Terlingua Medics, \$2,0000.00 to the Terlingua Fire Department, \$1,500.00 to the Alpine 4-H group, and \$1,200 to the Brewster County General Fund. CASI would like to continue to be a part of your community.

I have heard that someone is wanting to start a CASI Pod in the Terlingua area. As soon as I get more information on it, I will let you know. One of the members of our organization lives in your area: Van York, HC 70 Box 575, Terlingua, TX 79852.

INTERVIEW WITH JIM GRIFFIN, CASI CO CHILIHEAD OF THE YEAR 1992

Jim Grifffin reflects on: Becoming Interested in Cooking . . .

" I became interested in cooking chili as a teenager. Myself and an old friend, Arthur Dale Pearson, would get together the first cold spell every year and go to Shepherds Meat Market where another friend of ours, Tommy Calvert, was employed as the butcher. We would order several pounds of good chili meat and have him add a little tallow (fat). (You needed the grease to break down the spices.) This was the first trick he ever taught me. While Tommy cut the meat we would set around the space heater and discuss our plans for the day."

"Shepherds Market was a dying breed of grocery. The floors were made of wood, and would give and squeak while you walked on it. The Produce section was crates of regetables opened and leaned up against the wall on a table. The Cash Register was in the middle up front, with the credit slip holder hanging beside the cigarettes and snuff."

"After Tommy finished cutting and packaging the meat, we would stop at the spice rack to get what we didn't have at home. As I recall, the chili powder we favored at that time was a brand called Mexene, and we had never heard of beef base, chicken base, or any of those other high-tech ingredients."

"But nonetheless our chili was very popular in those days. We always had a crowd to eat and watch football."

"I guess the best pot we ever made was the day the 19666 Cowboys played the Green Bay Packers in the soon to be known as "The Ice Bowl". Bart Starr went over on a quarterback sneak on 4th and 1 with no time left to win for the Packers and then Coach Vince Lombardi."

"Jethro Pugh got frostbitten fingers that frigid day in Wisconsin."

"It was a tragic loss for Dallas fans everywhere but with the help of Budweiser and Bowl of Red, we survived."

His First Competition Cookoff:

"My first cookoff in competition was the North District Elks Championship held in Denton in 1984. Our team at that time won first place showmanship but didn't place in Chili. And that's where it all started."

His Favorite Cookoff:

"Without a doubt my favorite cookoff is the Terlingua Championship. My second favorite is my home town Pod annual cookoff held at the North Texas Fairgrounds in Denton. I placed lst in 1991 and this very special trophy adorns the wall in my Barber Shop. It has been a good conversation piece and brings back fond memories of cooking chili on those cold winter days at the shop."

His "First," First Place Win:

"My first ever first place was before I started cooking at CASI sanctioned cookoffs. It was at the Denton's Elks Lodge in 1985 or 1986. My first sanctioned first place was in Mach '91 at the Golden Triangle Pod cookoff."

His Pod Activities:

"Ours is a small pod but very active. We have members from all over the Chili Trail and we are very dedicated to promoting chili. We are especially involved in the

improvements to Rancho Casi de Los Chisos. I personally can visualize may creature comforts and at the same time retain it's natural state."

His Job in Real Life:

"Yes, I work, but not as much as I did before CASI entered my life in 1990. I had for the previous twenty years worked every Saturday in my Barber Shop in Denton but have recently started working Mon thru Fri. This allows Phyllis and myself to cook every weekend. As it turns out, it is the best decision I have made lately."

Sharing His Recipe:

"Of course I'll share my recipe with anyone. There are many recipes out there but I am convinced they are all variations of the one we use. You can find it in the back of the TOT cookbook listed there as "Chili Magic." Many thanks to Harvey West."

Improving Rancho Casi De Los Chisos:

"Well, as you all know, I think a water well would be nice. But working with the Show Teams and making it as easy as possible for them to have access to the sites and the time necessary to set up will pay off in the long run. I can't tell you how to accomplish this but I am confident that the Board of Directors is addressing this situation and without doubt will make the proper decision."

Last Comments:

"Being named as one of the CASI Chiliheads of the Year is a very special award. To be recognized for your efforts always makes you feel good and encourages you to do more. Although, I will admit it is easy for me to do since I enjoy working for CASI. Again, thank to those responsible for this award."


