Raven Nicole Homesley was born on March 29, 1998 at San Marcos, Texas and weighed 7 lbs. 12 oz..




The weather in early September in this part of the world is gorgeous.

I would like to try one more time to get ¹ CASI Great Peppers to approve a rule addition that would give equal points for Terlingua to those cooks who tie for the top 3 positions and 10th place at any CASI cookoff. My attempt 2 years was to long (3 pages). This proposal is 6 lines and says essentially the same thing as the 3 pages. This addition in no way changes the current tie breaking system for positions and trophies.

I apologize for ever calling my proposal a tie breaking rule change. My deepest thanks goes to the individual who developed the tie breaker rule. The following addendum will be submitted by the High Desert Pod for consideration at the Del Rio Great Peppers Meeting.

PROPOSED RULE CHANGE: ADD paragraph 3 to chili cooking rule F

TABULATING RESULTS:

PROPOSED

3. AWARDING EQUAL POINTS FOR TERLINGUA.

When 2 or more chilis are judged numerically equal the tied cooks receive equal points for Terlingua. For example if the first and second place chilis have tie scores both cooks receive 4 points. Cooks who's chili's tie for 10th place will be awarded 1 point.toward Terlingua. The CASI official of the cookoff must indicate on the tally sheet those cooks who carn points for tying higher positions.

RATIONAL:

CASI on occasion qualify cooks for Terlingua when they place 30th or lower in a State Open Cookoff. In 1997 3 cooks from one State Open qualified for Terlingua in 98 and none of them were in the top 10. Therefore CASI should also award points to those cooks whose chili earned them a tie. This proposal has no impact on sponsors, position/placement, trophies awarded or cooks not involved in the tie process. In the spirit of fairness lets award those cooks who tie the points their chili earned.


