Thanks to so many of you who made a memorial donation to Bryan's House in Jo's name. I am very pleased to let you know the total has reached \$1,300.00. I know Jo would have been very pleased at your act of kindness in her name.

I know how very special Jo and Wendell have been to all of us and I am very grateful that they chose Bryans House to receive your acts of love.

Bryans House responds to the needs of children and their families who are impacted by HIV/AIDS by providing 24 hours per day, 7 days per week medically-managed child care and community-based, family center support services.

Many HIV affected children cannot be placed in regular day care for many reasons; e.g., due to the child's fragile immune system, the number of daily medications, the child's medical complexities, lack of financial resources, and/or the stigma of the disease.

Overnight care may be needed when the child's health requires 24 hour nursing, or it may be needed when a parent is hospitalized, bedridden or simply unable to provide appropriate and consistent care for the child. This type of child care often diffuses an immediate or potential family crisis; or may prevent possible neglect, abuse, and abandonment of the child. Some children have no family home and live temporarily at Bryan's House until they have permanent placement with a foster/adoptive family. Others live indefinitely at Bryan's House because they are too sick to live with a foster or adoptive family.

Some children do have a family home but live temporarily at Bryan's House due to the child's health or family circumstances. Because the need for Bryan's House is so great we are moving into a new facility. I am very

pleased that your donations in Jo's name will allow us to honor her with a Memorial Brick in our new courtyard. I know Wendell plans on visiting our new facility and will be pleased with your visual sign of love for Jo.

Rules are Rules

Numbering cups. These rules provisions begin on page 3 of the 1999 Official CASI Rules, and, to save you the trouble of finding your Rule Book right now, I will excerpt the relevant portion:

5. **NUMBER THE CUPS** - After the number of chilis per judging table has been determined, an official will mark a judging designation (letter and number) on the side of each judging cup. This process will continue until all cups turned in are properly marked and taken to the appropriate judging tables. (Example: With three judging tables A, B, and C, cups are marked A1, A2, ..., B1, B2, ..., C1, C2, ..., etc. NOTE: The secret number taped to the side of the cup will remain unknown to the judges and official(s) writing the judging numbers on the cup sides.)
6. **RENUMBER THE CUPS AFTER EACH LEVEL OF JUDGING** - The judging designations (letter and number) on the cup sides must be changed at each level of judging. After each table has been tallied and the higher scoring chilis identified and removed for the next level of judging, each table monitor will immediately mark a large, highly visible "X" on the side and on the lid of each judging cup not forwarded to the next level of judging. Chilis to progress to the next level will be marked by an official in the above-prescribed manner.

There are many "local customs" and things each of us does in addition to the basic rule, but I believe this is a pretty easy rule to follow. Believe it or not, I recently saw a violation wherein all cups were numbered consecutively, with no table designation. Want to follow a chili through judging??

Some of the more helpful marking tips I've come across include using a red marker on the first round, and progressively darker (green, blue, black) markers for following rounds. This works well when chili seeps through styrofoam cups.

Another custom I like is marking out prior rounds' numbers **completely** so that neither the table designation nor the cup number is apparent. Although this is not in the rule, I think it is a very good procedure to follow.

Still another tip: when marking the "X" for cups that will not progress, place the "X" partially on the tape as well as the unprotected side of the cup.

Do you have tips you want to share? This is the place to share them!

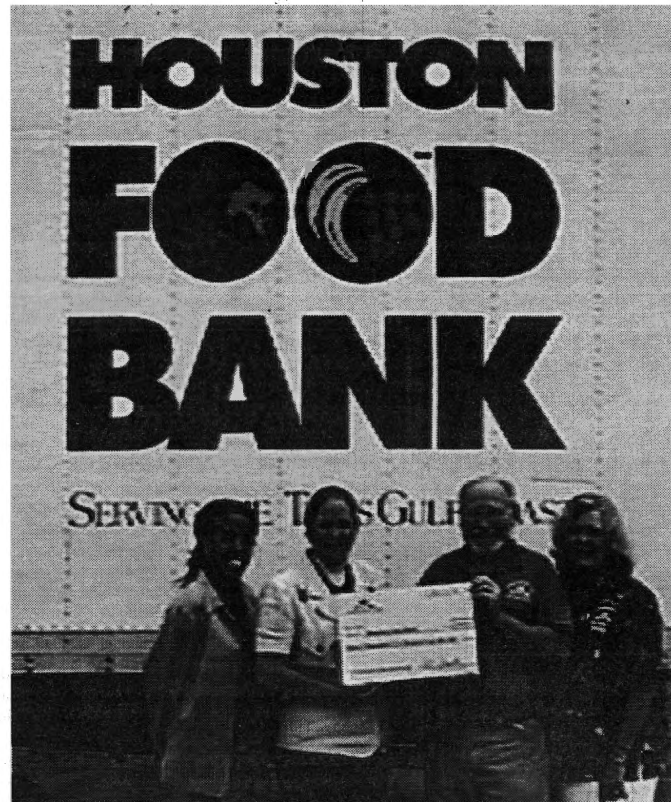

Why Chili Has No Beans

People are always asking why our chili has no beans. The contemporary reason for chili contests with no beans is that in 1951, a chili prophet by the name of John Haddaway decided to improve the quality of chili in the world. He knew in his heart of hearts that good chili had no beans and so

he wrote and preached about this. From this beginning, thousands of chili cooks and a couple of international organizations with associated foolishness have arisen. As part of this, millions of dollars have been raised for charities through the vehicle of competitive chili cookoffs.

The development of these competitive cooking events involved designing standardized rules to ensure non-biased judging and perhaps more importantly, to eliminate the notions that there were opportunities for some, to "cheat". Beans, by their appearance, by their variety and differences,

could allow some judges and promoters of events to select or de-select winners based on the appearance of the chilies, i.e., I might know that this is or is not Fred's chili because it has or doesn't have kidney, pinto and or red beans in it. As a competitive corollary, beans make it easier to mask bitter tastes associated with chili powders and they also provide vastly different flavors.

A perhaps better reason for no beans in chili is that historically, prior to the 1900s, chili was made without beans. Speculations surrounding the origins of "true" chili are numerous, but soaking dry beans and then boiling them for several hours makes beans a difficult dish for a cattle drive. I

believe jerky or just plain beef and biscuits were the typical fare for such adventures. As for jail houses, in the 1800s, I doubt that many served meat dishes to their guests.

The most reliable information on the origin of chili and their recipes comes from old cookbooks. Some early cookbook mention chili but do not include beans as an ingredient. The 1870s US Army Cook's manual contains a recipe for chili that does not have beans. In the Army, beans weren't included in official chili recipes until just before WW I. As a side bar, tomatoes weren't added to Army chili until improved canning techniques were developed prior to WW II. The earliest "sort of" recipe for "chili with beans" that I know of, comes to us from the 1880s and a boarding house cookbook which includes chili with beans on the border..."border" meaning, on the side.

Apart from all this is that chili has simply always been a Southwestern dish. There are stories (no recipes), of street vendors selling "true" chili on the streets of San Antonio before the American Civil War. We can also look at our Mexican heritage and find other evidence. Growing up as a kid in Arizona, at most native Mexican restaurants, a bowl of chili meant a bowl of meat, either red or green but...sorry, beans not included.

Anyhow, in this world the competition standard for chili cookoffs is chili with no beans. Because we like to cook and are friendly, we often include non sanctioned open or "anything goes" competitions so that "chili with bean" people can have fun to. Regardless, Chili Appreciation Society International (CASI), cookoffs are held for the purpose of bragging rights and raising money for charities and for having fun.

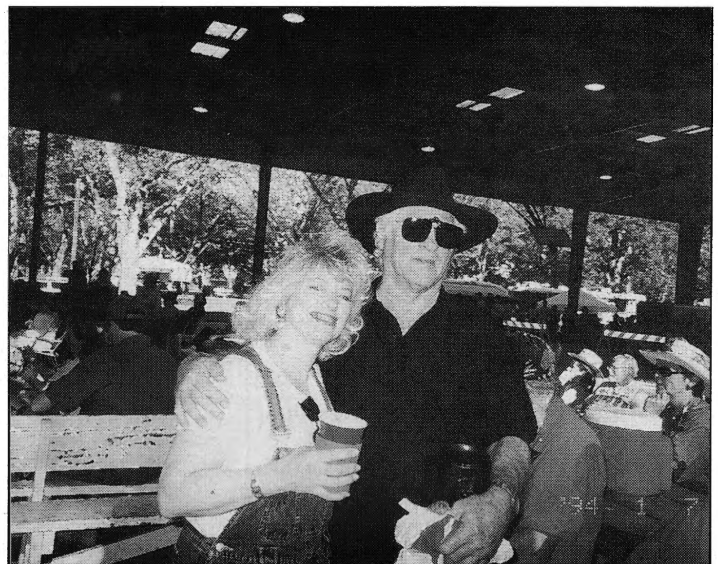

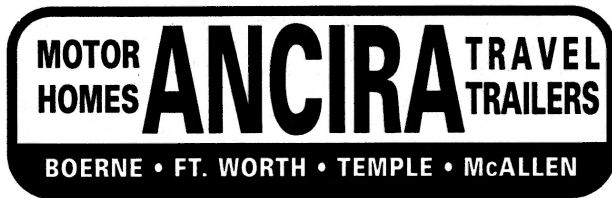

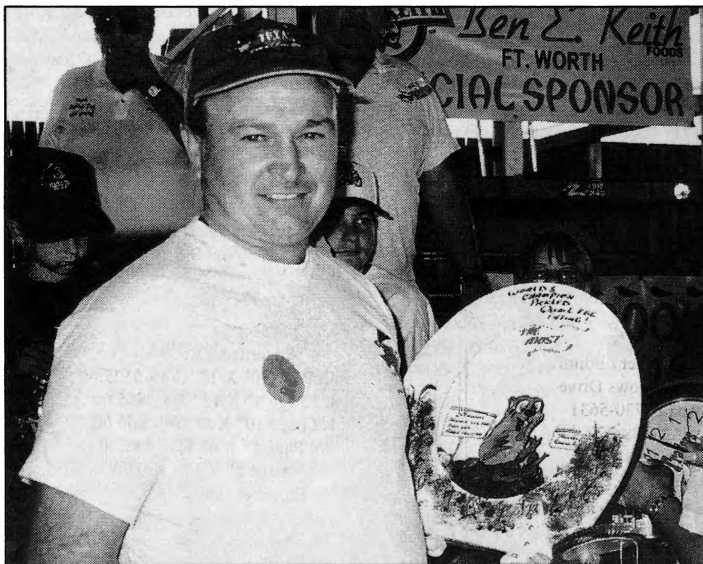
