#### NEW REQUIREMENT CONCERNING YOUR PROPANE BOTTLES

A new federal requirement is coming into EFFECT APRIL 1, 2002 requiring your PROPANE BOTTLES to be equipped with an OPD VALVE (Over fill protection device) in order for it to be refilled. Most propane bottles manufactured since January 1998 are equipped with this device. This does not effect Motor Homes or 100 pound bottles. The standard propane bottle used with BBQ grills is a 20 pound bottle. To check your propane bottle to see if it will meet the new federal requirement you can:

On the collar of the bottle, look for
the date it was manufactured. It
will be stamped by month/year such
as 9 98. If the year is 98, 99, 00, 01
it will be equipped with the new
OPD Valve. Also it should have a
label on the bottle indicating the
bottle has the new valve. Most
bottles equipped with the new
valve, the knob to open and close
the valve will be in a triangle type
shape. A few of the bottles

- manufactured in 1998 with the new valve might have the older round type knob.
- The next time you have your bottle filled – the person filling your bottle should be able to tell you if your bottle will comply with the new requirement (the person might not know this if the state you having your bottled filled in does not require them to be licensed to fill bottles – Texas requires all persons filling bottles to be licensed.)

If your bottle does not comply with the upcoming requirement you have two choices come April 1, 2002.

- Have your bottle refitted with a new valve at a certified propane dealer. However, ask what the price is before doing this because a 20 pound bottle costs more to do this than a buying a brand new bottle right now. However, I can only think the price of the 20 pound bottle is going to cost MORE when people all over the US start buying them to replace the ones they have when they can't get their current ones filled (Law of supply and demand). The price of a new valve for a 30 or 40 pound bottle (most travel trailers and fifth wheels) costs a more than a 20 pound bottle. I would also recommend you have your receipt for this each time you refill your bottle or have the dealer put a label on the bottle showing it has the new valve.
- 2. Buy a new bottle. Check the date of manufacture on the bottle collar to insure you are not getting on that has set in some warehouse of a couple of years. Right now in most cases, you can buy a new 20 pound bottle cheaper than having your current one fitted with the new valve. However I think this might change when the law comes into effect.

All propane bottles must be RECERTI-FIED 12 years after date of manufacture at any rate – so take this into consideration when you decide to have the bottle refitted or to buy a new bottle. A bottle has to be recertified every 5 years after the bottle is 12 years old. This is 12 years from the date stamped on the bottle, not 12 years after you bought it!!!!. I have filled new bottles people have bought that were 3 years old when they bought them.

I hope this information will help you avoid a major headache come April 1st if you go to have your bottle filled and you find out it can't be refilled until you refit your bottle with the valve (and most places that fill bottles are not licensed to change the valves).
