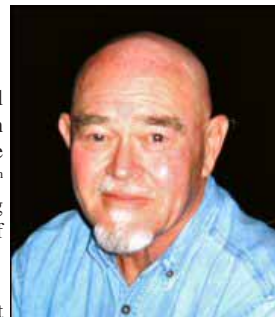

The CASI year 2008/2009 is fast drawing to a close. Here's hoping that each of you have scored enough points to be invited to TICC. If not, you still have a little bit of time left to get those points.

If you are planning to attend the Great Pepper's Meeting in Midland September 11 and 12, hopefully you have made your hotel reservations and completed and sent your registration to Patsy Childress. If you still need to register for the meeting, please do so immediately. If you need a copy of the registration form, please email me and I will send it to you.

The Annual Report from each Pod is due to me NLT August 15. This is my first year to process this report. So far, I have had good response. Thanks to all of you who have already sent me your report. The earlier you send them, the easier it is for me to get everything recorded and ensure that your credentials are correct and that you will be seated at the Great Pepper's Meeting. Those of you who have already sent me your report have done a great job of ensuring that your report is complete. Your response to my questions has been quick and any problems have been resolved easily. Please remember that any of your Pod Officers, as well as your Referees, must have their dues paid until September 30, 2010. This means that some of your members may have to pay their dues into 2011.

A problem has been identified by several of our Regional Referees. Many of our promoters submit CCO requests either electronically or send a paper request to Dorothy Williams. Some of them have not gone through a local pod or contacted their Regional Referee. The Regional Referee finds out about the CCO when it is published in the *Terlingua Trails*. Sometimes these CCOs are to be held at the same time as another CCO in the area. This causes a problem for all. We have identified this problem and are trying to resolve the situation. If the request comes through me, I will contact the Regional Referee and the promoter so that they are working together. We want each of our CCOs to be successful both for the cook and the charity. We have not resolved the problem as of yet, but we are working on a resolution and hope to come up with it in the very near future.

Holding a cookoff at a location that does not have insurance, and basically sharing the CASI insurance for their liability, could have catastrophic consequences to our insurance and ability to continue holding cookoffs.

The purpose of CASI insurance is to protect CASI and is **not** to protect those too foolish to protect themselves.

They call August the “dog-days” of summer. I am not sure why, but maybe because it signals the coming of the end of summer fun. I know, as a kid we did all the fun stuff in June and July and by August we were bored. There was nothing left to do but get in trouble, so we did. Chili cooks have it better; there are still many cookoffs to attend in August and September; lots of trophies and points to win. Go out and get ‘em.

If you are trying to qualify, and are unsure of your point count, now is a good time to check on them. September 30 is not a good time to check on your point

total. The CASI Central Information System (CIS) has made this quite easy. You can simply login and look up your points, my points, or anyone’s points. If you do not have a login, just contact our Executive Director, Janice Miller, and she can get you setup. If you are not a computer type, you can still call me (630-879-7934) and I will look them up for you. However, do it soon, don’t wait until it’s too late.

Last month I mentioned the role the Events Committee will play in helping Regional Open Championships through the application process. Just after writing the article for the *Terlingua Trails*, we received our first test in the form of an application for the Midwest Regional in Lenexa, Kansas. A copy of the application was sent to each committee member and they asked questions. I verified the Region met the cookoff requirement. If I could not answer the committee’s question, we asked the applicant. When we were done, we were satisfied that the application complied with CASI Rules and we recommended it for approval by the CASI Board of Directors. The timing worked out so it could be presented at the Director’s Meeting in Little Rock, Arkansas. The approval process went quite smoothly.

One of the things we learned from this first experience is that the defining of a region’s boundaries will be a challenge for some applicants. The first obstacle to overcome is the notion that regions are bounded by state lines. This is no longer a requirement. A region may include an entire state, or it may include only part of a state. Or in the case of the Midwest Region, it may have both. One must define their region to meet the number of cookoffs and pods requirement. Currently, only the states of Arizona and Texas have designated Regions. Those exist for Regional Referee purposes, and we would like to keep them intact. This may seem confusing, but I can assure you the Events Committee has a good handle

Attention All Cookoff Promoters!

Apparently there is some misunderstanding about the deadline for entering your event in the *Terlingua Trails*. The deadline for publication is the 15th of every month. The *Trails* goes to the press on the 16th. If information is not received by the 15th, your ad will not appear in the next edition of the *Trails*, it will appear in the following month.. The rule book states that your ad must appear in the month prior to the event. SO, if you are having a cookoff in the month of July, you must send in your information before the 15th of May so that it will appear in the June *Trails*, which is the month prior to the event. Any cookoff that fails to appear in the month prior to the event will be placed on Advertising Probation.

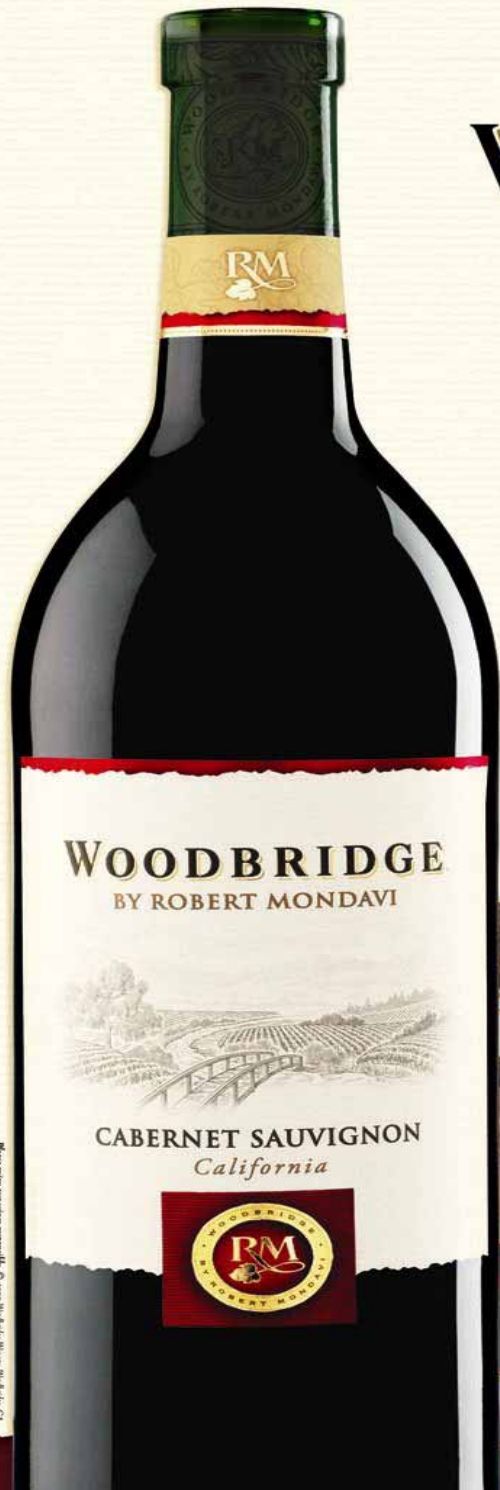
