

President's Message to the Great Peppers

When I took over as President last year, I knew I had some large shoes to fill of those who came before me, and I thank each of them for the job they did that paved the way.

Having recently read Jim Collins' bestseller "Good to Great", I came to realize that CASI is a good organization, but I know it can be a great

organization and, likewise, we have good Pods that can become great Pods. How do we get there?

We need to think of CASI as a bus. The bus needs passengers. These are the CASI members; the driver is the Great Peppers and dispatchers are the Board of Directors.

The question then becomes "Where do we want to go?" If we don't know where we want to go, how will we know when we get there? As with any organization, there are detours and potholes along the way. We can navigate these hazards, if we come together and work as a team.

That's not to say that we don't have some very strong Pods out there, but we have to be cognizant of the problems that Pods are experience. If we all don't provide the proper information and allow for input and accept change from time to time, we'll never grow. Information is the key to growth and growth is a key element in making a good organization great.

We don't need to assign blame but search for understanding and learning through a collaborative effort. Pointing fingers and assigning blame does no good and is detrimental to any organization. In the movie "Meet the Robinsons",

If you are a new promoter, please be sure to contact me so that we can identify a Referee for your chili cookoff. We are always glad to have a new promoter and a new cookoff. If there are questions, do not hesitate to contact me.

It is almost time to journey to TICC. I am looking forward to seeing each of you. Please, if you are a Great Pepper or a Regional Referee, be sure to stop by the Official Shirt table and get your shirt. If you would like to help me during the registration time, please let me know. I need a couple of people who can help me during this time.

This will be my seventeenth TICC and each one is different and better than the last one. This year promises to be just that. The 1500-mile trip to Terlingua is an interesting adventure. The changing landscape and climate going from north to south is remarkable. Odd as it may sound, I am looking forward to that drive again later this month.

Because the Directors are required to be on site Monday morning, I will be leaving Illinois on Saturday morning, October 31, 2009. I should have all September cookoff paperwork by Friday, October 30. This year

because TICC is so late, you do have the full thirty days to get September paperwork to me. However, why wait? I would be very pleased to have all the September cookoffs wrapped-up by, say the 15th of the month. It would make some late-qualifying cooks very happy as well. Nevertheless, it is very important I have all the September paperwork before I leave.

You will notice that there are no delinquent cookoffs again this month. If you find yourself in a situation, where you might not be able to get a cookoff's paperwork to me in time, first contact me and then bring the paperwork (or a copy of it) to Terlingua. We want to do everything possible to make sure those qualified for TICC, get to participate at TICC.

Registering for TICC and receiving your judging cup is an exciting experience. Here is some information to help make it a smooth experience.

The hours of registration will be Thursday, November 5, 2009: 10:00 AM to 3:00 PM. Friday, November 6, 2009: 11:00 AM to 2:00 PM. The Saturday late registration hour will be 8:00 to 9:00 AM, Saturday, November 7, 2009. All registration will be behind the presentation stage.

Showmanship registration will take place at a station next to chili registration where it is usually held. Old 320 registration, as well as the Friday events registration, will also be behind the presentation stage.

CASI Rules require that you must be a paid-up member of CASI in order to cook or perform showmanship at TICC. There will be an opportunity to pay dues at registration. However, you can speed up your registration process by paying (new or renewal) before you get to Terlingua.

Five years ago, we initiated a policy of showing a photo ID for chili registration. It worked well, and four years ago, we extended it to include showmanship registration. It is not our desire to inconvenience anyone, but as we grow (now over 325 cooks annually), we feel this measure is necessary to protect the integrity of the registration process.

The wristband policy is essentially unchanged from recent years. However, some confusion remains, so we will attempt to explain it. Each qualified cook and show team captain is entitled to free admission to TICC. I prepare a Gate List that has all qualified cooks and show team captains on it. The gate personnel work from this list, so there is no need to bring your qualification card or invitation. The list is computer-generated so there is little chance that your name would not be on the list, if it were supposed to be on the list. If you were to arrive at the gate and your name was not on the list, you would be required to pay the admission fee and directed to see me to resolve the problem.

Qualified cooks are allowed one contestant wristband for themselves and one for their companion (spouse or partner).

Qualified show team captains will be given only one contestant wristband at the gate. All other people accompanying them will be required to pay the admission fee. When registering for showmanship, they will be allowed contestant wristbands for their team members: three additional (four total) if participating in small show, and seven additional (eight total) if participating in large show. The one-person show entries will not get any additional wristbands.

Each cook and show team captain who participates in TICC is entitled to a contestant shirt. They are distributed when you register for chili or show. Invariably, we will have some extra shirts. On Friday at 2:30 PM, we will allow someone to pick up a shirt for a qualified cook or show team captain who is unable to attend this year's TICC. The person picking up a shirt

must produce the qualification card of the cook or show captain and the cook or show team captain must be current on their CASI dues, just as if they were present and competing. Shirts will be dispensed on a first come first serve basis as long as the supply lasts. There is no guarantee on sizes.

Finally, as always, if you are unable to reach the stage for registration due to a medical situation, we will come to you. Just have someone notify me and we will get you registered.

TICC Gate Policy

QUALIFIED COOK: Each listed **qualified cook** receives one (1) wristband. A husband and wife who are both qualified receive only one (1) wristband <u>each</u>. A second wristband will be given to the qualified cook if their spouse or friend <u>is with them</u> and are not qualified. **Qualified cooks DO NOT** receive additional wristbands if they are also Old 320 members and/or captains of a show team.

SHOW TEAMS: Each listed **Show Team Captain** receives one (1) wristband <u>only</u> if they are <u>NOT</u> qualified to cook or an Old 320 member. Qualified cooks or Old 320 members **DO NOT** receive wristbands in addition to the Show Team Captain wristband.

<u>Members of listed Show Teams</u> will pay to enter the gate and receive a spectator's wristband. They will then proceed to the registration area behind the stage and will be reimbursed for their entry fee and given the appropriate wristband.

OLD 320: Each listed Old 320 member and one (1) guest receive wristbands only if they are NOT qualified to cook or show. Qualified cooks or show team captains DO NOT receive wristbands in addition to the Old 320 wristband.



"A View From The Top of an Ole Chilihead"

When you read this it will be time to start chasing those points again. The new year brings new opportunities. I hope the weather gets cooler and everyone has good luck this year.

I was going to write about C.A.S.I./CASI this issue but changed my mind when I got to the GP meeting in Midland, Texas. In talking to cooks from all over this great nation of ours, I am still hearing that the same problems exist in our Pods. These problems include recruiting and retaining new members, low attendance at Pod meetings, and a lack of understanding about the functions of a Pod and how to run a successful cookoff.

One year ago at this meeting, I wrote about pods going out and getting new members and putting on more cookoffs. It ticked a few people off and I got some e-mails whining about how their areas are so different and nothing would work for them. It seemed to me that the common thread through these e-mails was, "We are a six point state and we want to keep it that way". What I wrote then will work, but some people will have to get off their lazy butts and go to work.

I am happy to say my home pod (Classic CASI) did pay attention and went out and proved pod members working together can accomplish a lot. Previously, we had low attendance at meetings. We now average between twenty and thirty at every meeting. You really can accomplish a lot when your attendance quadruples. But it will not happen without work and dedication by the majority of the members. How did it happen?

- 1. We recruited new members. We were not looking to just increase our membership roll but to get members that would be active and involved
- 2. How do you make your new members active? You have to mentor each one individually. Give them a job in the pod, explain the workings of a pod the correct CASI way. Teach every one of them to monitor and how to run judging by the book. (It's amazing how many areas of the country still don't run judging correctly. I heard this complaint more than any at the GP meeting. I was certainly surprised.)
- 3. Here is the part of mentoring with which some of you will have a problem. You will have to give the person you are mentoring a good recipe to cook that will get them some points. If you give them a BS recipe that you know won't be successful, it's a waste of time, will cause your new member to give up and make you look like a self centered *expletive*. Remember, once the new cook has a taste of success, the hook is set. Yes, you will have to compete against them and your recipe at cookoffs, but it is a great feeling to see them get points even when they are kicking your butt. Remember, CASI was started to have fun, relax, raise some money for charity and keep a level playing field for all cooks. This is a game and if you take it too seriously you become a negative force and defeat the purpose you think you are accomplishing.
- 4. Recruit (friends and strangers, your potential new friends), teach (the way CASI and pods work), mentor (stay with them as long as it takes even if takes a whole chili year or more).
- 5. It is simple, but it takes a lot of work and dedication.

This will get results. Classic will have twelve to fifteen new cooks that will be qualified and cooking at TICC this year for the first time. When the TallyMaster knows your local area code by memory, you're doing a good job. We don't consider our new members new anymore. They are now qualified to recruit, teach and mentor on their own.

Two of our new members put on their first cookoffs this year. Kathy Auten of Comanche Crossing and Sabrina Klietz of Country RV had cookoffs at their places of business. These cookoffs worked with their charities and made them an integral part of the cookoffs. I had my doubts about the one at the RV location. It was going against the only two ICS cookoffs held in Texas this year in San Antonio, the weather was still in the hundreds, it was September and I thought most cooks were already qualified.

Well, I was wrong. It was one of the best cookoffs I have attended in a long time. Sabrina and the charities got out and advertised the event. Spectators showed up in the heat. Cooks were well fed on Friday and Saturday nights and food booths were

open both days. Good money was raised for the two Volunteer Fire Departments. There was a good turn out of cooks. Three cooks qualified and three got up to the eleven point plateau. The cookoffs were run professionally from registration through judging and refereeing. But it didn't just happen. A lot time and work went into the preparation.

Working together with new members, getting them involved and continuing to mentor them will result in new members and their retention. We can and should all set a goal this chili year to bring in a new cook and set as a continuing goal, the retention of that cook. CASI and Pod memberships have a lot to offer, and with continuing efforts on our part, we can continue to grow in chili, charity and fun.



Let's start from the beginning. Back in 1993, there was a chili cookoff in Berryville, VA. Being very familiar with Berryville, having tubed the Shenandoah many times, met and befriended many of its residents, and joined its VFW. So come chili day, I fired up a charcoal cooker in the open and began preparing a cast iron skillet full of chili - you know - ground beef, beans, onions, tomatoes, peppers, sausage - the works

Before long, I was advised I needed to be cooking under a shelter. Didn't have one, but a friendly vendor loaned me an old one he wasn't using. Then people started coming by asking for samples. I obliged by doling out a small ladle full from my skillet, barely having enough left for the turn-in sample. Most remarked they loved my chill, it was "real chili", not that meat and gravy stuff the other cooks were handing out. Felt pretty good about that until awards time and, lo and behold, my number wasn't called. The cookoff was over, so even though it was a fun day, I packed up and headed to the banks of the Shenandoah for another night of serious beer drinking, etc. with my Berryville buds.

Fast forward to 1994 and another chili cookoff in Berryville. This time I had a shelter, but still didn't know any better than to fire up another skillet full of my home style chili. Same result. The people loved it but no mention of my number at awards time. This time though I chatted it up with some of the seemingly fun-loving folks I recognized from the previous year. It was fun and very rewarding. Had a margarita or two from Richard King's fire extinguisher and met the Kings, Bauers and Koltz' among others. They were all very friendly and clued me in about the meat and gravy, Texas style, chili thing. Little did I realize how significant meeting and talking to these chiliheads would be.

They asked me, in spite of the results or lack thereof, if I had fun that day. I most certainly had. They apprised me of another cookoff a few weeks away in Arlington, VA, gave me a sample recipe or two, and encouraged me to come cook there with them. I did and actually got a point that day, even though the significance of that wasn't to really register with me for a while. After that, there was another cookoff and an all night party camping at the King's home in Clifton, VA. Now we're getting the bug and having some great times.

Somewhere I got a listing of more chili cookoffs being held later in the year. There was one in Havelock, NC coming up in October. Since my Dad lived in NC, a few hours from that cookoff and I love to travel and meet new people, I decided to go down to Havelock and try my luck there. Wow!
